

**WAIVER AND RELEASE OF LIABILITY**  
**READ CAREFULLY – THIS AFFECTS YOUR LEGAL RIGHTS**

IN CONSIDERATION for myself and/or my minor child being permitted to participate, volunteer, plan, organize, prepare, aid, and/or observe, in any way, in the Lemon-Aid 25 Event (the “Event”) encompassed by this agreement (the “Agreement”), I agree as follows:

I, on behalf of myself and/or my minor child, knowingly, intentionally, and voluntarily assume all of the risks and liabilities arising from myself and/or my child’s participation in the Event and hereby release, waive, discharge, and covenant not to sue Lemon-Aid Project, Inc., a California Non-Profit Corporation, its officers, agents, contractors, or employees (hereinafter referred to as “Releasees”) from any and all liability, loss, damage, or claims, therefore on account of injury to the person or property, or resulting in death of the undersigned, whether caused by the negligence of the Releasees or otherwise, while the undersigned is participating, volunteering, planning, organizing, preparing, aiding, and/or observing, in any way, in the Event, or when in, upon, or about the premises or any facilities or equipment therein in connection with the Event.

I, on behalf of myself and/or my minor child, hereby agree to participate, volunteer, plan, organize, prepare, aid, and/or observe, in any way, in the Event at my own risk. I understand the Event and related activities have inherent risks and dangers, including but not limited to personal injury to me, my minor child, my person, or property, and that as a condition of being permitted to participate, volunteer, plan, organize, prepare, aid, and/or observe, in any way, in the Event, or related activities, I must and hereby do assume and accept all risks of harm, loss, or injury to me, my person, or property arising from, relating to, or connected with, the Event. Inherent risks and dangers may arise from, but are not limited to, those associated with premises liability, products liability, personal injury, the set up and break down of equipment, serving food and beverage, cleaning, selling tickets, staffing volunteer stations, and/or patrolling the Event. I, on behalf of myself and/or my minor child, understand that any decision to participate, volunteer, plan, organize, prepare, aid, and/or observe, in any way, the Event, is completely voluntary and does not entitle me to any compensation, salary, wage, payment or reimbursement of any kind.

I, on behalf of myself and/or my minor child, hereby agree to defend, indemnify, and hold harmless the Releasees and each of them from any and all liability, loss, damage, or claims, therefore on account of injury to the person or property, or resulting in death of the undersigned, whether caused by myself and/or my minor child or by the Releasees or otherwise, while the undersigned is participating, volunteering, planning, organizing, preparing, aiding, and/or observing, in any way, in the Event, or when in, upon, or about the premises or any facilities or equipment therein in connection with the Event.

I, on behalf of myself and/or my minor child, hereby further expressly agree that this Agreement is intended to be as broad and inclusive as is permitted under all applicable laws and regulations, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

I, on behalf of myself and/or my minor child, further expressly agree that in the event of a medical emergency or sudden illness, Lemon-Aid Project, Inc. has my permission to perform or obtain whatever medical emergency treatment that may be necessary for the named individual(s) below.

I, on behalf of myself and/or my minor child, further irrevocably grant Releasees permission to use and own the copyright to any photography, videotape or other likeness of myself and/or my minor child while participating in the Event for future promotional purposes.

I, on behalf of myself and/or my minor child, further agree that I have read, understand, and agree to comply with the rules and safety provisions established for the Event and all related activities activity, and further agree and acknowledge that I am free to have my own legal counsel review this agreement if I so desire.

I, on behalf of myself and/or my minor child, have read, understand and hereby do voluntarily sign this Agreement; agree that no oral representations, statements or inducements apart from the foregoing written agreement have been made; and agree that this Agreement may not be modified except in a writing signed by both myself and a duly authorized person on behalf of Lemon-Aid Project, Inc.
